KEY RESPONSIBILITIES OF GOVERNORS

Setting the School Vision

Governors establish the strategic direction and vision that guides the entire school community.

Accountability for Performance

Governors monitor and hold school leadership accountable for educational outcomes and standards.

Financial Oversight

Governors ensure financial integrity and probity to support sustainable school operations.

Compliance and Improvement

Governors ensure compliance with legal requirements and promote continuous school improvement



RELATIONSHIP BETWEEN GOVERNORS AND SCHOOL LEADERSHIP



Constructive Partnership

Governors and school leaders must work collaboratively to ensure effective governance and school improvement.

Clear Roles

Role of the Chair


The Chair leads the oversight of school performance evaluation and ensures accountability frameworks are implemented.


Performance Data Evaluation

Regular self-assessment enables governing bodies to identify strengths and areas for improvement effectively.


Enhancing Performance
